Legacies to charitable organizations are not subject to estate tax. You can also designate Cohen Veterans Bioscience as a beneficiary of your accounts, including brokerage and retirement accounts, to receive distributions upon your death. This is a quick and easy way to remember a charity in your estate plan, and a gift from a retirement account can have significant income tax (as well as estate tax) benefits at death.

HOW IT WORKS
